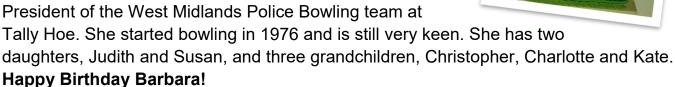




### Happy 90th Birthday to Barbara Baker Mason Cottages, 19th March 2016

# Friday Knitters

Pictured below are the ladies from the knitting group at Mason Cottages, who regularly meet up on a Friday. Audrey Mary Heard, an 'adopted' resident at Mason Cottages, who regularly visits the scheme, together with Sylvia Morrison, Muriel Bentley, Barbara Baker and Elaine Holyoak (who all live at our scheme in Erdington), helped to knit 'twiddle muffs' at the request of Walsall Manor Hospital's Older Person's Mental Health Team. This was after it was discovered that these greatly helped patients who get anxious and move their hands a lot. The 'twiddle muffs' have attachments to both the inside and outside, which include buttons, ribbons and pom-poms, enabling people to do something with their hands. This helps to calm them down.

Judith Toase (Scheme Manager at Mason Cottages) is a member of the Soroptimist International of Great Britain and Northern Ireland (SIGBI), which helps to improve the lives of women and girls locally, nationally and internationally, and they also asked if the group of knitters at Mason Cottages would like to knit these — which they did with great enthusiasm. Other knitters included Maureen Grant who is also a resident at Mason Cottages. The mother of Chris Jones, the Trust's Sheltered Housing and Care Services Manager, has a craft group in Tamworth and they also heard about the request from Walsall Manor Hospital.

The local SIGBI group in Walsall have also knitted a lot of these and it was one of their members, Barbara Housiaux, who originally suggested the idea and held a

coffee morning at her house, where the photo was taken (on the right).

Maureen Grant showed the 'twiddle muffs' to her son who was visiting from Germany and they are now knitting them there too!

### EMERGENCY CALL OUTS - When to call the repairs team...

You will be aware that our staff attend emergencies when our offices are closed in the evening, weekends or bank holidays, to carry out repairs to prevent a health and safety hazard or to avoid major damage to a property.

We know that this service is much-valued by residents and we are keen that you continue to use it when you require assistance.

However, sometimes residents call out staff for reasons that are neither emergencies nor the Trust's responsibility, and that can prevent our staff attending real emergencies elsewhere in the Trust.

<u>Please remember</u> the Trust reserves the right to make a £50 charge to a resident if our emergency out-of-hours service has been called out unnecessarily in circumstances that do not constitute an emergency.

If you are unsure about what constitutes an emergency please contact your Scheme Manager or Keith Terry, our Property Services Manager.

## The Queen's 90th Birthday



No doubt you will be aware that, it was the Queen's 90th birthday on 21st April 2016. From the countless television programmes, newspapers and photographs which have recorded the Queen's life over the past 90 years, you may think that you know everything there is to know about the longest reigning monarch in British history.

There are, however, many interesting facts that you may not know about the Queen...

For instance, in 1945, Princess Elizabeth joined the army and worked as a mechanic. When her parents, the King and Queen, visited her at the base she was wearing overalls and working on a lorry engine. Because of this, she is said to be one of the only Royals who could change a tyre and spark plug!



She collected coupons for her wedding dress. In a time of post-war austerity, the Queen collected rationing coupons in order to pay for the materials from which her wedding dress was made.





Queen Elizabeth married her distant cousin Prince Philip in 1947 at Westminster Abbey and the ceremony was broadcast live on radio to 200 million listeners worldwide.

The Queen officially does not require a passport to travel. Exempt from strict immigration laws, the Queen can move as freely in and out of border control as she pleases because British passports are issued in her name.

In honour of the Queen's 90th Birthday residents at Mason Cottages celebrated with a party, held on Thursday 21st April 2016. The Communal Hall was beautifully decorated in patriotic colours, and residents enjoyed a delicious buffet. ## Life Stories...

## Muriel Bentley, Mason Cottages (Born in 1928)

In 1961, George, my late husband, to whom I was married for over 60 years, decided that he would like a pub of his own, and in November that year we became pub managers.

We moved to a little pub called 'The Royal



George' in Aston Cross and our customers were nearly all 'brummies'. The pub had a really nice atmosphere and we'd have a sing-song on Saturday nights. We also had a barman, who

would throw people out if they were playing up! We really enjoyed our time there but only stayed until June the following year.

We were offered a new pub and were taken to see the new site. The new pub was named 'The Farthings' because it was built on a site where cottages used to be called 'The Farthings', so we had to keep the name. In September 1962, the pub was opened and the Brewery decided they would sell beer

for 1 farthing per pint, just for one hour between 6pm and 7pm – thinking nobody used farthings anymore. However, children were selling

outside for
sixpence each,
so during the
first hour the
pub was open it



was very busy. In the first hour we took 1,400 farthings and sold out of beer which was supposed to have lasted us a week! 4 farthings are worth about 1p in today's money and a pint roughly cost 1/7, so a farthing a pint was a marvellous deal!

The Brewery was not expecting the promotion to work as well as it did because farthings were going out of circulation at that time. As the opening of the pub was advertised in the local newspaper (unbeknown to us) there were consequently many visitors—but Muriel's favourite drink is a gin and tonic with no ice and a slice of lemon!

Following this, people used to send us farthings, which we took to Father Hudson's



homes in Coleshill because they would make some money out of them. They were Catholic homes and 'The Farthings' still exists today in Castle Bromwich.

We stayed at 'The Farthings' for four happy years before moving on to a pub called 'The New Inn' in Erdington, situated on Summer Road. We stayed there for 12 months before moving to 'The Gas Club' (now Hollyfields Sports Club) on Woodacre Road (pictured right as it is today). It was a lovely club. In the summer we had cricket and in the winter we had football. We had lots of different activities going on throughout the year such as cricket, tennis and bowls. We had a big playing field and three or four footballs teams used to make use of it. We always had a pot of tea ready for the teams on a Sunday morning which they enjoyed.

on an afternoon tea, which included meat, salad, bread and butter and, of course, jam We had many more happy years together and cakes.

We coped well whilst raising our two children, John and Janet. They were of a similar age with just two years' difference between them. While we were down in the bar, they used to play upstairs. They

settled in quite well to that kind of life and it was a particularly exciting time for them at the Gas Club with the large playing field. John would also enjoy watching the

television or going to a football match. It was a good time and we



thoroughly enjoyed it. I don't think we'd get those happy years the same today.

I particularly enjoyed Sunday lunch times. Wives gave their husbands permission to come away for the morning while they cooked the lunch, and the men would be quite happy here. We also had a darts team and occasionally did suppers for them.

We stayed at the 'Gas Club' for four happy During the summer season, we used to put years and then decided to 'pack up' and move back to a privately owned house. and George later worked at a different brewery as a Cellar Inspector. I now live happily at Mason Cottages in Erdington.





### PENSION CREDIT

Did you know that one in five pensioners miss out on hundreds of pounds' worth of benefits they could claim? Does this apply to you? You may be surprised.

Recent research has shown that around 1 in 3 of the 4 million UK residents entitled to claim **Pension Credit** have never done so. As a result many are losing out not only on a guaranteed minimum weekly income but additional assistance from the Government. Claiming even a small amount of Guarantee Pension Credit can make you eligible for extra money as part of several other benefits including health costs and help with council tax.

### There are two types of Pension Credit - Guarantee and Savings

The first part is called Guarantee Pension Credit because it guarantees you a minimum weekly amount to live on. Currently, that amount is £155.60 for singles and £237.55 for couples. If your total weekly income is less than the amounts shown, we can help you.



The perks you can get when you are in receipt of Guarantee Pension Credit:

You may not have to pay Council Tax.

You don't have to pay for NHS dental treatment and you can claim help towards the cost of glasses or contact lenses and claim travel costs to and from hospital appointments.



If you are disabled, you may also qualify for a Severe Disability Addition, worth £61.85 per week.

As you can see, membership of the Guarantee Pension Credit club is a very good thing! You have nothing to lose by applying and everything to gain.

The second part is a Savings credit (for those aged 65 and over before April 2016) paid by the Government as a reward for people who have made a provision for their retirement in the form of savings or a private or occupational pension. The maximum weekly savings credit is currently £13.07 for singles and £14.75 for couples.

Unfortunately, benefits don't arrive automatically. You have to claim them, and 'if you don't ask, you don't get'

### NOTE TO RESIDENTS:

If a resident intends to move to other accommodation, in accordance with the Occupancy Agreement, he/she must give 4 weeks' Written Notice to the Trust.

Scheme Managers have copies of the necessary Termination Form that must be completed.

Residents should ensure that when they depart their home is left in good order, empty of all personal contents and any rubbish, and that all keys and fobs are returned to the Scheme Manager's office.

### Mike Smith, Sheltered Housing and Care Services Manager



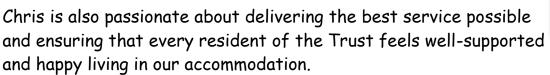

If you are retired or semi-retired The University of the Third Age (U3A) is a great way to develop old or new skills and interests that you never had time for before. It is also a way of meeting people and making new friends.

The University of the Third Age is a nationwide organisation that provides retired and semi-retired people with a way to come together and learn together, not for qualifications but for its own reward: the sheer joy of discovery! Members share their skills and life experiences: the learners teach and the teachers learn, and there is no distinction between them. In no way is it academic, in spite of its title!

A new branch of U3A has just started in Olton. It currently has fourteen interest groups, which are Book Club; Bridge; Embroidery; Family History; Gardening; Meals Out; Singing; Strolling; Sugar Craft; Tai Chi; Trips and Walking. Each group meets at regular intervals. They also hold a general monthly meeting at the United Reformed Church on Kineton Green Road. # Let's Get Cooking

### Chorizo and Soft Boiled Egg Salad

#### **INGREDIENTS:**

- 250g baby new potatoes, halved
- 2 eggs
- 112g green beans, trimmed
- 122g chorizo rings, sliced
- 1/2 garlic clove, sliced
- 1 tbsp sherry vinegar
- 1 tbsp chopped parsley
  - 1. Cook the potatoes in a large pan of boiling salted water for 12 minutes and add the eggs after 6 minutes.
  - 2. Add the beans for the final 2 minutes.
  - 3. Drain everything and cool the eggs under running cold water.
  - 4. Meanwhile, fry chorizo slices in the pan for 1-2 minutes, until they begin to crisp. Remove them from the pan with a slotted spoon and set aside, leaving the oil from the chorizo in the pan.
  - 5. Add the garlic to the pan and cook gently for 1 minute.
  - Remove the pan from the heat, stir in the vinegar and parsley, then toss with the potatoes, beans, chorizo and seasoning. Finally, de-shell the eggs, cut into quarters and add to the salad.

### History Around Us...

The canal boat children's home in Erdington

On the opposite side of Erdington town centre to Mason Cottages, is a little known piece of local history which compliments the original and continuing objectives of the Trust - the education of children in need.

Unlike our orphanage the Wood End Hall Children's home was a canal boat children's hostel. It wasn't actually a children's home but a hostel providing temporary housing for canal boat children so that they could access schooling at Birches Green School in Erdington. The hostel had places for 29 children at any one time.

One of the main forms of transporting goods at the time was by narrow boat on the country's canal network. Whole families would live on their boats, constantly on the move collecting and delivering raw materials and goods on the route from Birmingham to London or Liverpool.

The education of children from the canals had been fiercely debated in Parliament

since the 1870s, following the work of leading children's rights campaigner, George Smith. Though laws were passed in 1877 and 1921 to improve the living conditions of the children on the working canal boats, their educational wellbeing was largely ignored.

The canal boat families and their employers were, on the whole, strongly opposed to the children leaving the boats, as it would mean breaking up the families and losing a cheaper and often skilled workforce. Boaters conspired to swap children between families so that they couldn't be taken away or traced by inspectors.

Children did get some education from Sunday schools and charitable foundations including the Salvation Army.





However, the 1948 Children Act transferred responsibility to Birmingham point is now underneath the Gravelly Hill City Council and it was felt boat children should be given a hostel to enable them to attend school.

It is believed that Wood End Hall was the first hostel of its kind in England. It was ideally located, as Birmingham has a significant network of canals, and Wood End Hall itself is only a few minutes' walk from the junction of the Birmingham and Fazeley Canal, the Birmingham and Warwick Junction Canal and the Tame Valley Canal. Known as

Salford Junction, this canal meeting Interchange (Spagnetti Junction).

The hostel is thought to have closed in the 1960s, when commercial haulage by canal boats ceased, and the families finally moved off the boats.

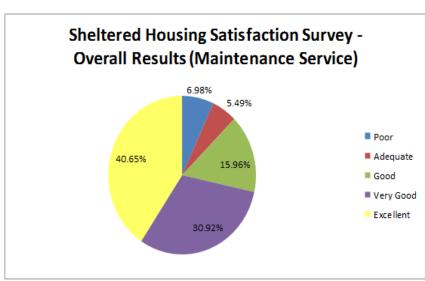
# What you said...

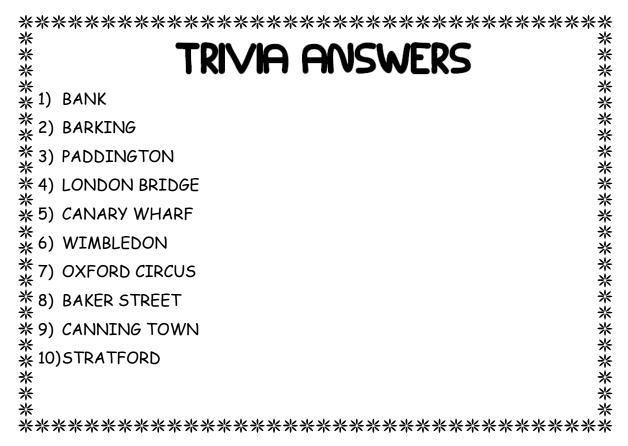
